Project Update

In the last issue of Al-Haqq it was reported that the quotations from the architectural companies had been received by the IHS, and all were much higher than what was budgeted. Once the design is completed it will be then submitted to the selected architect to be prepared in compliance with Canadian requirements, and then to the 3415 West Lake Mary Blvd #954152 construction companies who will be able to bid on the project.

Speakers, guests, and members of the Revert Muslim Association (RMA) gathered in the western Toronto city of Brampton in the middle of March for their annual Conference.



An Introduction to Ziyarat By Saleem Bhimji

[This introduction has been extracted from the recent publication of the Islamic Publishing House (<u>www.al-mubin.org</u> / <u>www.iph.ca</u>) entitled LOVE FOR THE FAMILY. It will be available soon via PDF and Android APP for a nominal price.

Aside from the *ziyarat* of the previous Prophets and Messengers, the most important people whom we must make every effort to visit are none other than the Prophet Muhammad (peace be upon him and his family) and his purified progeny – the Ahlul Bayt – whom are directly referred to in the verse of the Qur'an found in chapter 42 (Suratul Shura), verse 23 in which the Noble Prophet (peace be upon him and his family) was ordered by Allah (Glory and Greatness be to Him) to proclaim that in return of his lifetime of challenges, grief and anxiety to convey the teachings of Islam, the Qur'an and all that we hold sacred - that he asks for no reward "…*except love for the family…*":

. قُل لا أَسْأَلُكُمْ عَلَيْهِ أَجْراً إِلا أَلْمَوَدَّةَ فِي ٱلْقُرْبَى..)

Say: "No reward do I ask of you for this except the love of those near of kin."


Who are the "near of kin" of Prophet Muhammad 9? This is a question which many have inquired about.

In regards to the explanation of this verse, the famous Sunni scholar, Imam al-Tabarani, in his work, Mu'jam al-Tabarani al-Kabir quotes the following hadith: حدثتا محمد بن عبد الله ثنا حرب بن الحسن الطحان ثنا حسين الأشقر عن قيس جديتا محمد بن عبد الله ننا حرب بن الحسن الطحان ثنا حسين الأشقر عن قيس بن الربيع عن الأعمش عن سعيد بن جبير عن ابن عباس رضي الله تعالى بن الربيع عن الأعمش عن سعيد بن جبير عن ابن عباس رضي الله تعالى ولا الله ومن قرابتك هؤلاء الذين وجبت علينا مودنهم؟ قال علي وفاطمة وابناهما.

From Ibn Abbas, may Allah be pleased with them both, in which he said, "When the verse (*Say: No reward do I ask of you for this except love for the near of kin*) was revealed, we said: 'O Messenger of Allah! And who are 'the near of kin' – those upon whom having love for is an obligation?' He (the Prophet 9) replied: "They are 'Ali, Fatima and their children."

MOJEZA (MIRACLE)



Allah created this universe to work on the principle of causes and effects. Every effect has at least one associated cause. It is this ubiquity of causes and effects that makes the existence of universal laws possible. The power to break the link between cause and effect is either with the Creator Himself or with those who have been authorized by Him to do so. An event that shows the break between the link of cause and effect is called a miracle or – in religious terminology – a "mojeza".

Mojeza is one of the proofs of the truthfulness of Divine Guides appointed by Allah. This proof is so important that Qur'an goes to great lengths in mentioning several mojezas that were given to various nabis and rasools. Sulaiman could talk to animals, control Jinns, etc. The fire of Nymrod became cold and safe for Ibrahim. Eisa could give life to inanimate objects. Moosa could make his staff change into a python. tween them and the other people in the court? The difference was knowledge. To become magicians, they had acquired knowledge. This knowledge made them realize that what Moosa had done went against the natural order of things. They probably knew, as we know now, that the matter-energy content of the universe is constant and that matter cannot be created or destroyed. But they had seen matter, i.e., their ropes, being destroyed out of existence. And they realized that only the Creator had the power to do this.

As we can see from above, pondering over a mojeza can be mind-expanding. We have also seen that mojezas are important and that Allah bestowed mojezas on His Divine Guides, i.e. nabi, rasool, wali and imams. But I have noticed that these days, majority of the speakers from the pulpit seem to avoid talking about mojezas. This has come as a surprise to me and I have even directly questioned some of them. The invariable reply I get is something like this: "Our youth are growing up in a materialistic society and they would have a hard time understanding mojezas". I don't believe this is true. In fact material knowledge, taken with the right attitude, is helpful in better comprehension of Islamic concepts (as will be illustrated later). Either way, it becomes doubly important that we relate the mojezas and make them understand. Else we are leaving dark for them a part of our faith and beliefs.

Two particular miracles that are often presented as hard to explain are the returning of the sun (rad-ush-shams) for Imam Ali and the coming down of a star (at the time of aqd of Lady Fatima). To start with, let us tackle the mojeza of radd-ush-shams.


The objections raised in relating this mojeza are as follows:

In the light of modern knowledge, "returning of the sun" is not the right terminology because it is the earth that goes round the sun and not vice versa. The response to this objection is simple enough. "Returning of the sun" is based on a terminology that was in force in the language of the time and could refer just to the visual effect and not the actual event.

If such a major event (i.e. return or the sun or reverse rotation of the earth) is such an enormous astronomical event that if that had happened, it would have been observed in other countries and there would be records of it found in other cultures but no such records have been yet found. Response to this objection can be two-fold. First, no records may have been found but that does not necessarily prove that no records exist. Secondly, why is it necessary for the event to have been observed universally? One of the implications of the theory of relativity is that there is no such thing as absolute time. So the creator of time could very well reverse the flow of time for a limited region of space.

So what about the mojeza about a star coming down to earth and then going back to space? How is physically possible when we know that stars (and even planets) are humongous and coming of one such spatial body close to earth would have been catastrophic. In response to this, I would like to paraphrase the wordings of a religious scholar, Maulana Abbas Razvi (late) of Bombay. In a speech he had stated that according to his research, the heavenly body that came to earth at the time of the aqd of Lady Fatima with Imam Ali was not a star but it was the planet Venus. At Allah's command, the planet left its orbit started moving close to earth. As it approached earth, it proportionately lost its mass and volume. After performing its prescribed duty on earth, it went back to its original position in space, proportionately gaining the mass and volume it had originally lost.

In conclusion, narration of miracles of the Masoomeen is a praiseworthy act that can help us better understand our Leaders and better appreciate their closeness to Allah.

DIABETES MELLITUS:

This is due to insulin deficiency. Overeating gets the special cells of the pancreas (islets of Langerhans) over worked so it cannot meet the increased demand for insulin . Those cells may get tired, atrophy and causes deficiency of insulin .

Hamilton couple married 54 years dies 24 hours apart



On the morning of March 21, Ramzan Manek fought the shaking tremor in his hand and worked to dial the numbers on his phone. He was calling his wife.

It had been six years since my grandfather, 76, was diagnosed with Parkinson's disease. He had lost the ability to walk and was in a motorized wheelchair. He required 24-hour care at Macassa Lodge, but in this twice-daily conversation, he was strong and determined.

"Laila, it's Ramzan. Do you remember who I am? I'm your husband. I'm Ramzan."

He made that call morning and night, even though it broke his heart. My grandmother, Laila, 75, had Alzheimer's disease. She



had stopped recognizing him some time ago. Laila was being cared for by her son, my uncle, in the home she and my grandfather used to share. With those phone calls, my grandfather made sure the one thing she would never forget was the love they shared. He wouldn't get the chance to make his evening call to her that day. Late that afternoon, his beloved Laila died. It was as though the air left his body. Within hours, he was being sustained by an oxygen tank.

The next morning, he was not strong enough to be taken to her funeral, which, in Muslim tradition, happens the day after someone dies. Instead, her body was brought to him so he could say goodbye.

We hadn't even finished burying my grandmother when my grandfather's medical team called to say "come quickly."

Dozens of friends and family members rushed to see him.

He died a few hours later.

The couple died 24 hours apart, after 54 years of marriage. They are buried side by side in a Stoney Creek Mountain cemetery, the two graves so close together that the divider doesn't show. A single, large tombstone is being prepared. She's on the left and he's on the right, the same way they lay in bed for the 50 years they shared a home.

After coming from East Africa as refugees, the Maneks were part of the Hamilton area for more than 40 years. They were among the large diaspora of South Asians threatened with death if they remained in Uganda in the 1970s under dictator Idi Amin. They were forced to abandon cars, bank accounts and treasured possessions. They faced looters at gunpoint and left the country with only a five-shilling note, equivalent to only a few cents in Canadian currency. My grandfather hid the money in a cigarette pack so they could buy milk for their newborn son.

Ramzan held odd jobs before joining the City of Hamilton, where he worked in the finance department for 25 years. Laila kept the household running and raised their three beautiful children. Together, they helped settle an entire community of South Asians to the area. These were the glory days of Pierre Elliot Trudeau, when the welcome gates were open to immigrants and a message of multiculturalism became the mainstay.

They took that to heart, building a mosque in the area and caring for it for the next three decades as chairman and chairwoman of the association. Ramzan served on the mayor's race relations committee in the 1990s and the Hamilton police diversity board in the early 2000s. The pair got involved in politics and organized large interfaith gatherings, trying to eradicate racial and religious tensions against Muslims of all stripes. Together, they were honoured by every level of government for their charitable endeavours and volunteer work, and were even asked to be in attendance to meet Charles, the Prince of Wales, when he visited Hamilton in 1996. Apart from weekly Tiger -Cats games, which were my grandfather's favourite solo outing, Ramzan and Laila did everything side by side. Their tale is made even more amazing by the fact that they first met on their wedding night in 1960.



Yes, theirs is an incredible story of fate from a

traditional arranged Indian marriage. When Ramzan's mother knocked on a house rumoured to have five beautiful daughters in a tiny village in Tanzania, it was 21year-old Laila who answered the door..


"This is the girl for my son," his mother said right away, or so the story has been told over the years.

This spring, British scientists came out with a study saying it is possible to die of a broken heart after the passing of a loved one. We as a family can attest to that. Ramzan and Laila Manek committed to each other completely: mind, body and soul. So much so, that when she was ready to leave this world, he willed his body to do the same so they could finally be together again.

When we were at Ramzan's funeral, two people who didn't know one another came up to us with an unbelievable memory. They said my grandfather had made a promise to each of them many years before: "I want Laila to die before me so she doesn't have to shed a tear and suffer at my passing. Then, I will join her the next day, so she doesn't have to be alone."

He kept his promise to his beloved wife. We believe they are soulmates, who have been reunited. True love knows no limits. Remember that in your life today.

Time to Lift Veil on Saudi Arabia's Hijacking of Islam

Saudi Arabia has spent \$100 billion in recent decades spreading an extremist ideology.

Imagine an attempt to ban the veneration of the Prophet Muhammad. Go further and imagine a plan to level his tomb in Medina, the second holiest site in Islam, dig up his remains and rebury them in a secret, unmarked grave. Go further again and imagine the actual, systematic destruction, in the early years of Islam, of the tombs of the major figures, including the prophet's closest relatives.



What lunatic would even imagine going to these extreme lengths to provoke, insult and enrage Muslims? Well, the House of Saud, rulers of Saudi Arabia and guardians of the extremist ideology that fuels much of today's Islamist terrorism, wouldn't just imagine them. It does them.

In all the official rhetoric about freedom of speech in the aftermath of the Charlie Hebdo massacre, it is notable that there are two words that apparently must not be spoken: Saudi Arabia. Yet it is impossible to understand what is happening now without grasping the fact that the mentality of the killers is not a weird aberration. It is shaped by an official cult propagated by a government western states are anxious to appease at almost any cost. Saudi Arabia has spent about \$100 billion in recent decades spreading an extremist ideology, a hybrid of Wahhabism and Salafism, two versions of an Islam supposedly "purified" of its "foreign" influences.

Saudi Largesse

These are not ancient traditions. Wahhabism was born in the 18th century, Salafism in the 19th. And they are not "Islam" – Salafis and Wahhabis make up 3 per cent of Muslims. One of the more bizarre aspects of this ideology is that it involves attacks on things most Muslims regard as sacred. When western liberals wring their hands about giving offence to Muslims by depicting or representing the prophet, they miss the most important point. Cartoons in Charlie Hebdo are vastly less offensive to most Muslims than the destruction of early Islamic tombs by the Saudis. But of course self-appointed defenders of Islamic sensitivities, funded by Saudi largesse, won't tell you that.

In the last 20 years or so, the Saudis have destroyed hundreds of holy sites in Mecca to clear ground for the construction of hotels and shopping malls and around the Grand Mosque. Much of this is about money, of course, but the destruction is sanctioned by Wahhabi ideology and Saudi history. The Wahhabi sect regarded the veneration of sacred tombs as heretical.

The Wahhabis destroyed dozens of holy tombs in Mecca and Medina when they conquered those cities in 1806 and even attempted to level the prophet's tomb. They did the same when they reconquered the cities in 1925. This mania continues: just last year, a senior Saudi cleric prepared a detailed plan for the dismantling of the prophet's tomb. The followers of this ideology have continued to destroy sacred Islamic sites and tombs in Pakistan, Libya, Iraq, Syria and elsewhere.

Muslim Outrage

How do most Muslims feel about this? Outraged of course. A large survey in 2012 of opinion among Muslims in Western Europe, west Africa and Malaysia found 75 per cent of respondents believed the veneration of the graves of Muslim "saints" (Ziyarah) was essential or desirable.

For the vast majority of Muslims the running story of sacrilege and provocation is not a few cartoons in secularist European newspapers, it is the Saudi iconoclastic assault on veneration of the prophet.

Chapel Hill shooting: Three young Muslims gunned down in North Carolina family home

A family of three young Muslims has been shot dead in their home in a quiet neighbourhood of North Carolina in the US. Police have named the victims as 23-year-old Deah Shaddy Barakat, his wife, Yusor Mohammad Abu-Salha, 21, and her sister, Razan Mohammad Abu-Salha, 19.

Officers were called to reports of gunshots at 5.11pm at an apartment block largely housing academics and young professionals on Summerwalk Circle in Chapel Hill.

The victims were found shot dead at the scene, while some residents described not even being aware there was an incident until police arrived. Sources told local WRAL News that all three had been shot in the head.

A 46-year-old man, named by police as Craig Stephen Hicks, has been arrested on suspicion of three counts of firstdegree murder.

time), Chapel Hill Police said that a preliminary investigation suggested the crime was "motivated by an ongoing neighbour dispute over parking".


But the women's father, Dr Mohammad Abu-Salha, who has a psychiatry practice in Clayton, told the North Carolina News and Observer that he believed the shooting was based on the religion and culture of the victims.

"This was not a dispute over a parking space; this was a hate crime," he said. He went on to allege that Hicks had "picked on" his daughter and her husband "a couple times before."

"They were uncomfortable with him, but they did not know he would go this far," he said.


Police chief Chris Blue called the killing "senseless and tragic" and said the force's "thoughts are with the families and friends of these young people who lost their lives so needlessly".

He said: "We understand the concerns about the possibility that this was hate-motivated and we will exhaust every lead to determine if that is the case."



The shooting has been met with an outpouring of anger on social media, where people posting new pictures of the victims studying and playing basketball claimed they had been "murdered execution style".

Some compared the incident to the Charlie Hebdo shootings in Paris, and others called on Barack Obama and senior religious figures to condemn the attacks.



An American football and basketball fan, Mr Barakat was believed to be a dental student at the University of North Carolina and volunteered with a charity providing emergency dental care to children in Palestine.

He regularly posted on Twitter, and wrote in January: "It's so freaking sad to hear people saying we should 'kill Jews' or 'kill Palestinians'. As if that's going to solve anything."

UNC officials said Mr Barakat and Yusor Abu-Salha got married less than two months ago, in late December. She had been planning to begin her own dental studies in Chapel Hill this autumn.

And yet we never hear about this when the question of "insulting" the prophet or disrespecting the sacred traditions of Islam is raised in Europe. Why? Money. The Saudis have vast amounts of it and use it to fund mosques, schools and Islamic cultural centres all over Europe. A hundred billion dollars buys you a lot of silence. And that silence engenders one of the great hypocrisies of our times: a cartoon of the prophet is a provocation that deserves death but the destruction of his tomb is a religious duty.

This hypocrisy is underwritten by a tacit understanding among western governments: don't mention the Saudis. The house of Saud runs a vicious tyranny that, among other things, treats women as badly as apartheid South Africa treated blacks. While the Charlie Hebdo killers were going about their ultimate acts of censorship, the Saudi government was savagely lashing the blogger Raif Badawi for daring to promote public debate in his blog.

But the Saudis are "our" Islamist extremists and they're sending us lots of cheap oil right now. So when we talk about not insulting Muslims, we ignore what most Muslims regard as most offensive. And when we talk about confronting the nihilistic bigotry of extremist Islamism, we ignore the government that is pumping it into our societies through its promotion of a cult that most Muslims reject. It is long past time for democracies to take offence.

This year it is estimated that about \$16 billion would be spent on Valentine day gifts, cards and flowers. The more you spend the more economy flourishes.

According to Islam:

Is there any harm in love? Is love the most dangerous and lethal thing in this world? No not at all. Islam respects Love and affinity as the entire humans do on this earth. The only problem is that Islam only believes in legitimate love and relationships. Love between two spouses, between family members, between blood relations, between good friends. We very well know who these relations are with whom we can express our love. There are no special days in particular to show our love. We can show our love 24/7 to our ties.

Allah says in the Qur'an: "And among His signs is that He created for you mates from among yourselves, that you may dwell in tranquility with them and He has put love and mercy between your (hearts). Verily in that are signs for those who reflect." [Ar Room 30:21] The key words in the verse are - Mawaddatan wa Rahmah - which translates as Love and Mercy. The interesting thing to note about this verse is to notice the location of this verse along with the verses that precede it and those that come after. Allah mentions His Signs (Night/Day, Heaven/Earth, and Man/Woman) and He puts the feeling of Love and Mercy between spouses in the same value as the creation of Heaven & Earth. Now then how can we ignore such a great Sign of Allah?

The Prophet (PBUH) once said about Khadija (AS)," I was verily filled with love for her." This is how expressive our Prophet was, when he talked of love for his wife. However, today we find that many of us are shy to express our love. In fact, many consider it a sign of weakness to say "I love so and so" and they consider it a blow to their pride to tell their spouse, "I love you". But the Messenger (saw) was not shy to express his love of his wife. And notice that he didn't simply say, "I love her", but he said, "I was filled with love for her".

There is no such thing as love being forbidden in Islam, which encourages Muslims to love each other for the sake of Allah and express your love to your brother, but of course there are limitation to this, let us see Concept of Love in Islam Love is that beautiful feeling Allah (SWT) puts in the heart of a sincere, pious and god fearing couple at the time of their nikah. And this is a serious, long-term relationship in which both individuals are content and comfort-able with one another.

Pagan origins of Valentine's Day

The first information about this day is found in pre-Christian Rome, when pagans would celebrate the "Feast of the Wolf" on February 15, also known as the Feast of Lupercalius in honour of Februata Juno, the Roman goddess of women and marriage, and Pan, Roman god of nature. On this day, young women would place their names in an urn, from which boys would randomly draw to discover their sexual companion for the day, the year, and sometimes the rest of their lives. These partners exchanged gifts as a sign of affection, and often married.

Christian Influence:

When Christianity came onto the scene in Rome, it wanted to replace this feast with something more in line with its ethics and morality. A number of Christians decided to use February 14 for this purpose. This was when the Italian Bishop Valentine was executed by the Roman Emperor Claudius II for conducting secret marriages of military men in the year 270. Claudius II decided that single men made better soldiers than those with wives and families, so he outlawed marriage for young, single men, who made up his military. Valentine defied Claudius and performed marriages for young couples in secret. When his actions were revealed, Claudius put him to death. Another version of the story says that Valentine was a holy priest in Rome, who helped Christians escape harsh Roman prisons where they were often beaten and tortured. Valentine was arrested and sent to the prefect of Rome for this. He found that his attempts to make Valentine renounce his faith were useless, and so recommended he be beaten with clubs, and later beheaded. This took place on February 14, 270.

According to the Catholic encyclopedia, there are at least three different Saint Valentines, all of whom are Christian martyrs of February 14. One of them is described as a priest from Rome (as mentioned above), another as bishop of Interamna (modern Terni), and the third from Africa. It was in the year 496 that Pope Gelasius officially changed the February 15 Lupercalia festival to the February 14 St. Valentine's Day to give Christian meaning to a pagan festival. The holiday became popular in the United States in the 1800's during the Civil War. After the American adoption of this day it got popularized in Europe again. In rest of the world it reached in last 50 years with the blessings of media and attractive merchandize. Many schools, universities and clubs prepare elaborate functions and parties. Many will argue that Valentine's Day is a day of joy and harmless fun. But is it really?

From an Islamic point of view Valentine's Day is wrong for the following reasons:

1. It invites people to the relentless pursuit of sexual freedom

In Islam all forms of intimacy and passion are confined to the relationship of marriage. Anything beyond this is not acceptable. The culture of promoting the satisfaction of desires and passions in an uncontrolled manner is unhealthy.

Islam recognizes that we are human and can succumb to human weakness, so it has provided strict safeguards for our own sake. The Quran mentions clearly: "Do not come near to adultery. It is a great sin and an evil way." (Surah Israa, Verse 32)

2. Valentine's Day is based on pagan culture

Cupid, the virtually naked, arrow-shooting character, which shoots people with its arrows to make them fall in love, is a remnant of Roman pagan times. Cupid is described as the son of Venus, the Roman god of love and beauty. Cupid's picture is frequently found on Valentine cards and other paraphernalia.

3. Imitation is strictly forbidden in Islam

If someone wants to celebrate it just on a family or spouses scale innocently, just to follow the tradition. It is not necessary to do it on Feb 14th. They can do it any day by exchanging gifts, love and emotions. It is because when you live in a country or a society where different traditions are followed, one feels tempted to it. Being a good Muslim It should be decided in the light of Quran and sunnah what is wrong and what is right.

(WASHINGTON DC -- April 7, 2015) UMAA mourns the loss of Ayatollah Dr. Sayyid Muhammad Bahr Al-Aloom, who passed away today in the holy city of Najaf.

Ayatollah Bahr Al-Aloom was born in Najaf in 1927 to a family of an important religious, social and political history. He graduated from the Najaf University with a degree in Religious Studies, and later received his PhD degree in Islamic Sharia from Cairo University in 1979.

Sayyid Bahr Al-Aloom was the first Iraqi cleric politician to sign the document "Democracy and Human Rights in Iraq" in 1988, which shed light on Saddam Hussein's violations against the Iraqi people.

Ayatollah Bahr Al-Aloom was a longtime opponent of the rule of Saddam Hussein. By 1992 he had moved to London where he opposed Saddam's rule for many years.




He was an active member of London's Shi'a community and was the head of AhlulBayt Centre in the UK. From the early 1990s, he was a critical component of anti-Saddam activities, helping to coordinate Iraqi Shias, Sunnis, Kurds and other groups.

After Saddam Hussein was deposed in 2003, Sayyid Bahr Al-Aloom was appointed to the Iraq interim governing council. He was also appointed to the nine-member rotating presidency of Iraq. He was the first president of the council, in an interim capacity, serving in that position from July 13, 2003, until August 1, 2003.

Leaders of neighboring countries have sent their condolences to the Bahr Al-Aloom family.

Ayatollah Dr. Sayyid Muhammad Bahr Al-Aloom is survived by several children and grandchildren. Memorial services are to be held in Najaf, Iraq and Dearborn, MI, USA.

<u> 10 Common Místakes Parents Make Today</u>


What may be ingrained in our culture is not always in the best interest of our kids

Mistake #10: Worshipping our children.

Many of us today live in child-focused communities. We're raising our kids in child-focused homes. Our children love this, of course, because our lives revolve around them. And for the most part we don't mind either, because their happiness is our happiness. It thrills us to do for them, buy for them, and shower them with love and attention.

But it's important to keep in mind that our children were made to be loved, not worshipped. So when we treat them like the centre of the universe, we create a false idol, turning a good into an ultimate. Rather than kid-focused homes, we should strive for God-focused homes. Our chil-



dren will still be loved, only in a better way, one that promotes selflessness over selfishness.

Mistake #9: Believing our children are perfect.

One thing I often hear from professionals who work with children (counsellors, teachers, etc.) is that parents today don't want to hear anything negative about their kids. When concerns are raised, even concerns voiced out of love, the knee-jerk reaction is often to attack the messenger. The truth can hurt, but when we listen with an open heart and mind we stand to benefit. We can intervene early before a situation gets out of hand. It's easier to deal with a troubled child than repair a broken adult.

Mistake #8: Living vicariously through our children.

We parents take great pride in our children. When they succeed, it makes us happier than if we'd done it ourselves. But if we're overly involved and invested in their lives, it gets hard to see where they end and we begin. When our children become extensions of us, we may see them as our second chance. Suddenly it's not about them, it's about us. This is where their happiness starts getting confused with our happiness.

Mistake #7: Wanting to be our child's Best Friend.

When I asked a Scholar to name the biggest mistake he sees in parenting, he thought for a moment and then said, "Parents not being parents. Not stepping up to the plate to do hard things." Like everyone, I want my children to love me. I want them to sing my praises and appreciate me. But if I'm doing my job right, they'll get mad and not like me sometimes. They'll roll their eyes, moan and groan, and wish they'd been born into another family. Seeking to be our child's BF can only lead to permissiveness and choices made out of desperation because we fear losing their approval. That's not love on our end; that's need.

Mistake #6: Engaging in competitive parenting.

Every parent has a competitive streak. All it takes to stir this monster in us is another parent giving his or her child a leg up at our child's expense. I hear these stories a lot at the junior high and high school levels, stories of broken friendships and betrayals due to one family blindsiding another family. The root of this is fear. We fear our children will get left behind. We fear that if we don't jump into the craziness, and pull out every stop to help them excel early, they'll be stuck in mediocrity the rest of their life. Children need to work hard and understand that dreams don't come on a silver platter; they have to sweat and fight for them. But when we instil a "win at all costs" attitude, permitting them to throw anyone under the bus to get ahead, we lose sight of character. Remember - Character may not seem important in adolescence, but in adulthood it's everything.

Mistake #5: Missing the wonder of childhood.

The other day I found a Strawberry Shortcake sticker on my kitchen sink. It reminded me how blessed I am to share my home with little people. Raising small children can be hard, monotonous work. At times it's so physically and emotionally exhausting we wish they were older to make our life easier. We're also kind of curious who they'll grow up to be. What will be their passion? Will their God-given gifts be clear? As parents we hope so, for knowing which strengths to nurture enables us to point them in the right direction.

The pressures on kids start way too early. If we really want our kids to have a leg up, we need to protect them from these pressures. We need to let them have fun and grow at their own pace so that they can explore their interests without fear of failure and they don't get burned out. Childhood is a time for free play and discovery. When we rush children through it, we rob them of an innocent age they'll never pass through again.

Mistake #4: Raising the child we want, not the child we have.

As parents we harbour dreams for our children. They start when we get pregnant, before the gender's even known. Secretly we hope they'll be like us, only smarter and more talented. We want to be their mentors, putting our life experiences to good use.

But the irony of parenting is that children turn our molds upside down. They come out wired in ways we never anticipated. Our job is to figure out their inherent, God-ordained bent and train them in that direction. Forcing our dreams on them won't work. Only when we see them for who they are can we impact their life powerfully.

Mistake #3: Forgetting our actions speak louder than words.

Sometimes when my kids ask a question, they'll say, "Please answer in one sentence." They know me well, for I'm always trying to squeeze life lessons into teachable moments. I want to fill them with wisdom, but what I forget is how my example overshadows my words. How I handle rejection and adversity... how I treat friends and strangers... whether I nag or build up their father... they notice these things. And the way I respond gives them permission to act the same. If I want my children to be wonderful, I need to aim for wonderful, too. I need to be the person I hope they'll be.

Mistake #2: Judging other parents -- and their kids.

No matter how much we disagree with someone's parenting style, it's not our place to judge. Nobody in this world is "all good" or "all bad"; we're all a mix of both, a community of sinners struggling with different demons.

We never know what someone's going through or when we'll need mercy ourselves. And while we can't control judgmental thoughts, we can cut them short by seeking to understand the person instead of jumping to conclusions.

Mistake #1: Underestimating CHARACTER.

If there's one thing I hope to get right in my children, it's their CORE. Character, moral fiber, an inner compass... these things lay the foundation for a happy, healthy future. They matter more than any report card or trophy ever will. None of us can force character on our kids, and at age 10 or 15 character won't mean much.

Children care about short-term gratification, but we, as parents, know better. We know that what will matter at 25, 30 and 40 is not how far they once threw the football, or whether they made cheerleader, but how they treat others and what they think of themselves. If we want them to build character, confidence, strength and resilience, we need to let them face adversity and experience the pride that follows when they come out stronger on the other side.

It's hard to see our children fall, but sometimes we have to. Sometimes we have to ask ourselves whether intervening is in their best interest. There are a million ways to love a child, but in our quest to make them happy, let us stay mindful that sometimes it takes short-term pain to earn long-term gain.



Salmon Patties

Ingredients

- ◆ 1½ cups cooked salmon OR canned salmon, drained
- 1 large egg, lightly beaten
- ◆ 1 small onion, finely chopped
- 1 stalk celery, finely diced
- 1 green onion, finely chopped
- 2 Tbsp fresh parsley, chopped
- 3-4 Tbsp olive oil
- ◆ ½ tsp freshly ground pepper
- 1 tsp salt to taste
- 1 cup corn meal (optional)



Directions

Place salmon in a medium mixing bowl. Flake apart with a fork; remove any bones and skin. Add egg, onions, parsley, celery, salt and pepper; mix well. Shape the mixture into 8 patties, about 2-3 inches wide. If desired roll them in corn meal (optional).

Heat the olive oil in the pan over medium heat. Cook salmon patties until the undersides are golden, 3 to 4 minutes. Serve with lemon wedges and tartar sauce.

Kadayif Dessert

Ingredients

1 bread kadayif 41/2 cups of sugar 2 tablespoons of lemon juice grated peel of 1 lemon cream

Directions

1- heat 41/2 cups of sugar with 5 cups of water in a pot and stir until the sugar dissolves, bring to a boil then add in lemon juice and lemon peel boil for 5 minutes, then remove from heat.

2- bread kadayif has two layers. remove from second layer turn it upside down and put it back on top of the other layer.

3- put the kadayif in a deep tray pour hot water over kadayif until it is completely covered. place a heavy plate on top to prevent the kadayif from rising above the water cover the tray and let sit to allow the water to be absorbed 4- once the water turns tepid, gently press the kadayif to sieve out any excess water. Pour prepared syrup over it and cook on a loe heat, occasionally turning the tray and pouring in more syrup from the edge of the tray until the kadayif absorbs the syrup and gets thicker.

5- let cool then slice and remove onto serving plates. top each slice with cream
